Selection Process

A panel of judges who represent the rental equipment industry, as well as *RER* editor, Michael Roth, and *RER* managing editor, Brandey Smith, will review the entries. Entries will be judged in their category based on innovation, product design, safety, fulfillment of a need in the rental market and influence on the industry.

The panel of judges will review all category finalists to determine which product represents the greatest innovation and most benefits the rental industry. *RER* will recognize the grand winner, along with all category finalists in its December 2007 issue. The grand winner and category will be reviewed extensively in December *RER*. All entries will be reviewed, along with pictures, in *RER* magazine in January and February 2008.

How To Enter

If your products were introduced to the market between August 1, 2006 and July 31, 2007, they are eligible for the *RER* Innovative Product Award competition. To enter follow these steps:

1. Review the official rules listed below.
2. Fill out an entry form.
3. Submit the following materials:
 - > Maximum of 150 words of descriptive copy
 - > Three photos/illustrations of your product and your company logo (300 dpi, .tif. or .jpeg in PC format) Submit the photos and logo on a disc (CD, floppy, Zip, etc.)
 - > Your entry fee of \$495 per entry. Make check payable to Prism Business Media. Entry fees cannot be invoiced.
4. Submit your completed entry, materials and fee to the address listed on the entry form. All items must be postmarked by August 1, 2007.

Official Rules

Entry Form: An official entry form or a copy of it must accompany all entries. Incomplete entry forms or entries with false or misleading information will be disqualified and entry fees forfeited.

Eligibility:

All entries must meet these criteria:

- > The product must be available for purchase in the United States.
- > The product must first be available for purchase between August 1, 2006 and July 31, 2007. (Redesigns or significant modifications occurring within the entry dates will be considered at the judges' discretion and must be presented as such.)
- > An employee or an authorized representative of the manufacturer that produces the product must sign the entry form.

Entries: Your entry must be submitted according to the above guidelines. There is no limit to the number of products each company may enter. Each entry should be submitted separately, but a single check covering the full amount for all the entries may be submitted. Entries that do not meet required guidelines or ones that are not submitted properly may be disqualified without refund.

Deadline: All entry materials, including the payment of \$495 per entry, must be postmarked by August 1, 2007.
